This is regarding Compliance Report submitted by KPR Institute of Engineering and Technology, S.F. No. 204/2, 204/4, Arasur, Coimbatore- 641 407, Tamil Nadu for the UG Civil Engineering program which was accredited by NBA in Tier-II for academic years 2018-19 to 2020-21 whose validity of accreditation had expired on 30.06.2021. The program was granted accreditation for the Academic Year 2021-22 i.e. upto 30/06/2022 on account of present pandemic situation due to Corona Virus..

2. An Expert Team conducted data verification of the program on 1st May, 2022. The report submitted by the Expert Team was considered by the concerned Committees constituted for the purpose in NBA. 3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.


4. The program has been granted accreditation for further 3 years. KPR Institute of Engineering and Technology, S.F. No. 204/2, 204/4, Arasur, Coimbatore- 641 407, Tamil Nadu should submit fresh online application through eNBA portal at least five months before the expiry of validity of accreditation mentioned above.

5. The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to KPR Institute of Engineering and Technology, S.F. No. 204/2, 204/4, Arasur, Coimbatore- 641 407, Tamil Nadu as a whole.
