Following points have been discussed during the 8<sup>th</sup> Board of Studies meeting.

### RESOLUTIONS:

#### 1. Minutes of Action taken on the 7<sup>th</sup> BoS meeting:

The members suggested the following points in the 7<sup>th</sup> BoS meeting are implemented by the department

- (i) Dr. M. Vijayalakshmi suggested to utilize textbooks and reference materials that have been published within the last 5 years.
- (ii) Dr. Ramalatha Marimuthu suggested to include Generative Learning with topics such as GPT and Transformer technology.
- (iii) Mr. S. Sudarsun recommended to include optimization techniques book in Mathematical Foundation for Data Science course.
- (iv) Mr. S. Sudarsun suggested to give open choice of programming language instead of restricting to the use of R programming.

## **2. Syllabi of Open Elective under Regulations 2021**

- (i) Dr. M. Brindha suggested to include speech processing and sentimental analysis in 5<sup>th</sup> unit.
- (ii) Dr. M. Vijayalakshmi suggested at least two course outcomes can be in apply level and PO values can be in level 1 or 2 for understand level.

Following are the suggestions given by BoS members regarding Curriculum and Syllabi under Regulations 2021 to the standing committee of the Academic Council for discussions:

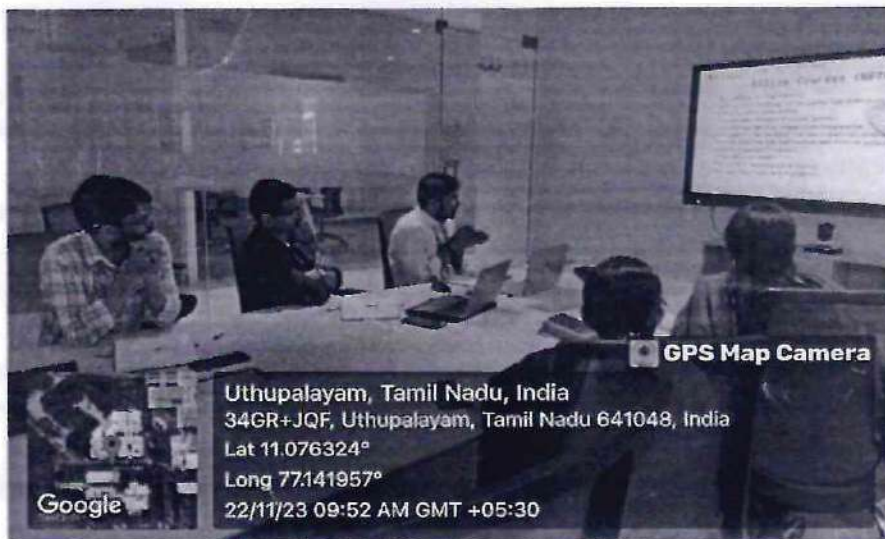
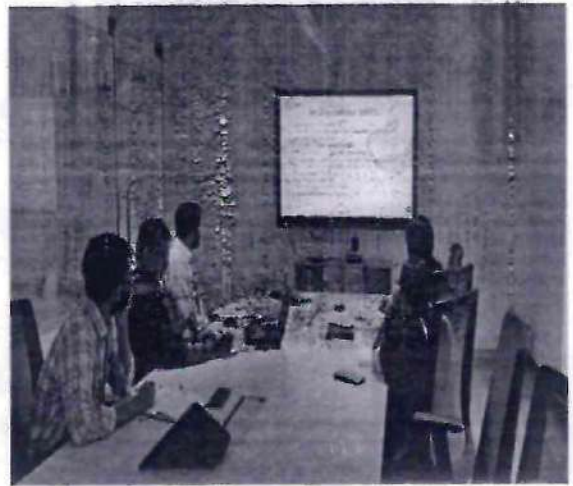
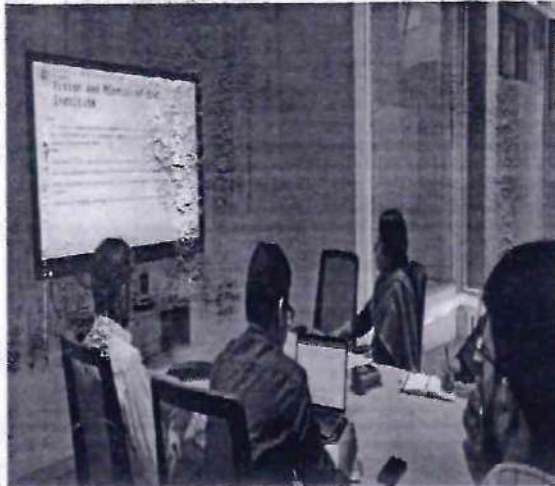
- (i) All the value added courses suggested in DCC meeting are approved by the BoS members.
